

## **Appendix A.4 Environmental Policy Statement**

Directors, management, and supervisory staff have responsibilities and accountabilities for the implementation of the policy and must ensure that environmental issues are given adequate consideration in the planning and day-to-day supervision of all work. All employees and subcontractors are expected to co-operate and assist in the implementation of this policy, whilst ensuring that their own work, so far as reasonably practicable, is carried out without risk to themselves, others, or the environment. This includes co-operating with management on any environment-related matter.

We will ensure that employees are aware of this policy and their individual responsibilities within it, by an appropriate programme of training and awareness.


To achieve these objectives, it is the policy of JRP Services Limited to establish and maintain an effective environmental management system based on the requirements of BS EN ISO 14001

As well as its certification to BS EN ISO9001:2015 it is also certified to BS-EN-ISO9001:2015, ISO45001:2018, Achilles UVDB/Verify & CHAS
